New Fire Marshal Requirements for Clan Tents

- 1. A Clan's tent must have a single canopy, they may not be directly adjacent to another canopy.
- 2. Canopies must be anchored by stakes in the foot of the support legs, or by staked lines. All tents must be set up a minimum of 10 feet apart from the support legs or the staked lines of any adjacent tents.
- 3. All canopies are required to have an affixed certificate of the flame resistance of the tent fabric material. See (NFPA 1:25 2.2.).
- 4. Each tent must have a visible and easily accessible portable dry chemical fire extinguisher with a minimum 2A-10BC rating.

Please also note that the Kindleberger Park regulations prohibit any alcohol consumption or open bottles of alcohol on the premises. Please comply with these requirements to help us keep our great relations with the City and Park officials.
